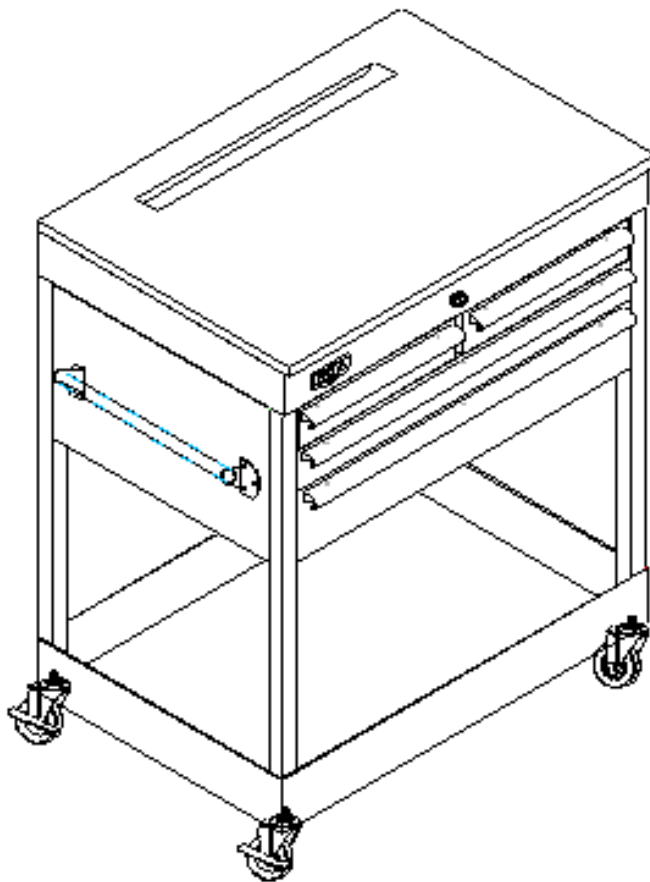

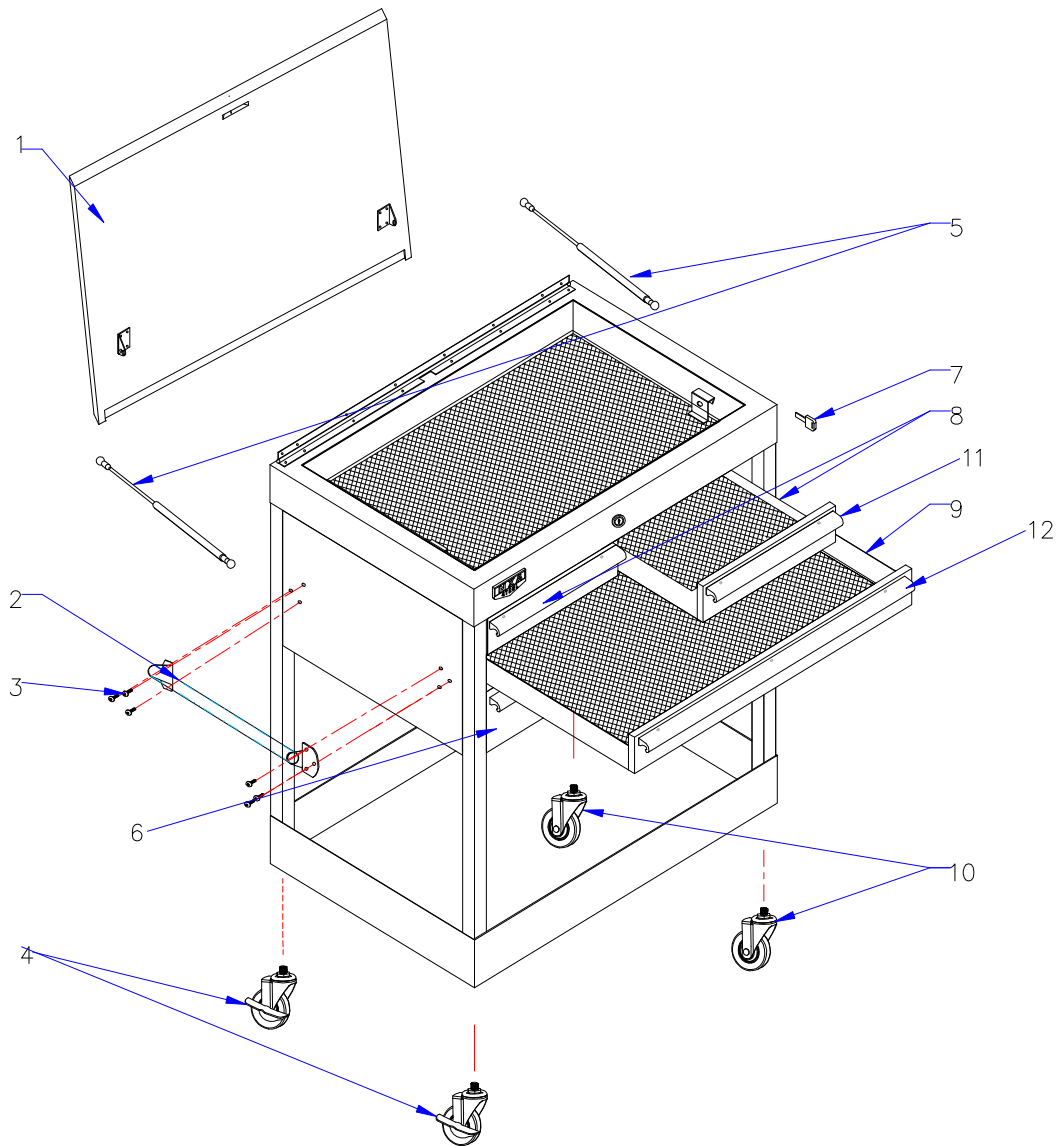

# Exploded View of 960-0007



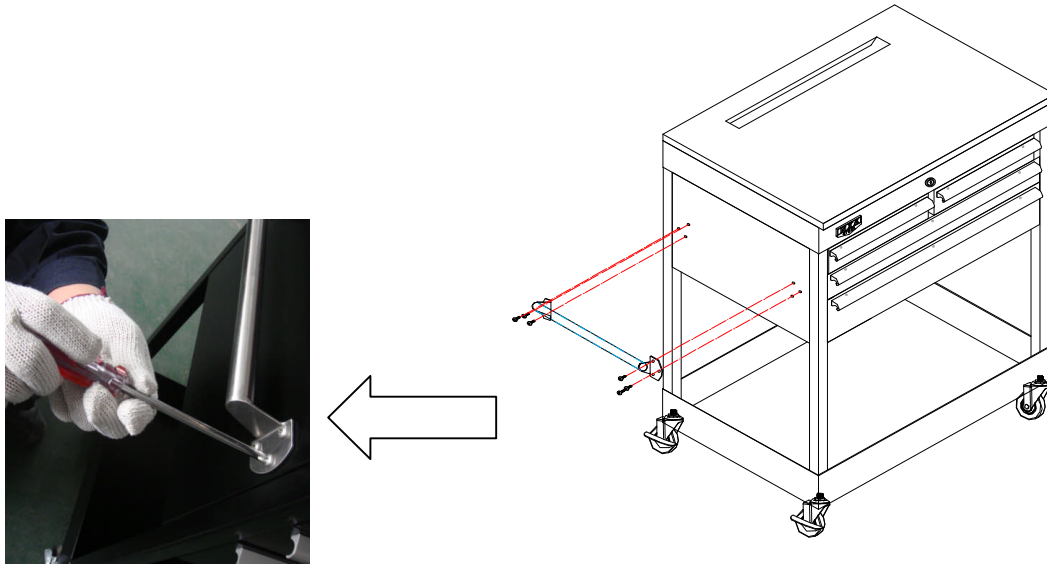

## Assembly Instruction

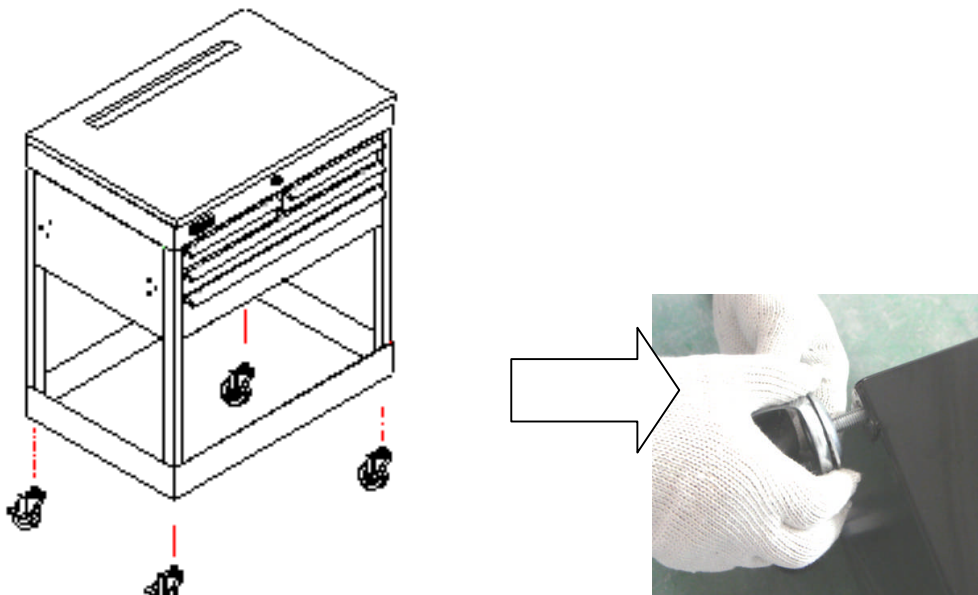
### 1. Handle Installation:

Take out the 6 screws from the hardware pack, line up the handle with the holes, insert the screws and firmly tighten the screws.



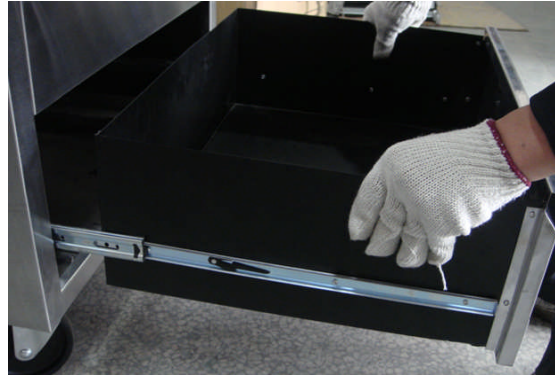
### 2. Wheels Installation:

Push the post on each caster in to the receptacle in each leg until it is firmly seated (2 casters with brake on the left hand side when facing the cart).



## **-How to remove the drawer?**

Slide the drawer out until it is fully extended. Note the black plastic levers on both sides of the drawer. Depress the levers and then slide the drawer out.



## **CAUTION**

- **Do not use the drawers when the lid is locked**
- **Close the drawers before close the lid if you want to lock them.**
- **Assemble the side handle to make it easier to move the mobile cart.**

Nexgrill Industries warrants to the original consumer-purchaser only that this product (**Model #960-0007**) shall be free from defects in workmanship and materials after correct assembly and under normal and reasonable home use for the periods indicated below beginning on the date of purchase. The manufacturer reserves the right to require that defective parts be returned, postage and or freight pre-paid, by the consumer, for review and examination. **Please retain your receipt or proof of purchase, as it may be needed as documentation that you are the original purchaser for extended warranty coverage.**

- **All PARTS: 1 Year LIMITED warranty**  
*\*Does not cover cosmetic issues like surface corrosion, scratches and rust.*

Upon consumer supplying proof of purchase as provided herein, Manufacturer will repair or replace the parts which are proven defective during the applicable warranty period. Parts required to complete such repair or replacement shall be free of charge to you except for shipping costs, as long as the purchaser is within the warranty period from the original date of purchase. **The original consumer-purchaser will be responsible for all shipping charges (and customs charges in Canada) of parts replaced under the terms of this limited warranty.** This limited warranty is applicable in the United States and Canada only, is only available to the original owner of the product and is *not transferable*. **Manufacturer requires reasonable proof of your date of purchase. Therefore, you should retain your sales receipt and/or invoice.** Defective or missing parts subject to this limited warranty will not be replaced without registration or proof of purchase. This limited warranty applies to the functionality of the product ONLY and does not cover cosmetic issues such as scratches, dents, corruptions or discoloring by heat, abrasive and chemical cleaners or any tools used in the assembly or installation of the appliance, surface rust, or the discoloration of stainless steel surfaces. Surface rust, corrosion, or powder paint chipping on metal parts that does not affect the structural integrity of the product is not considered a defect in workmanship or material and is not covered by this warranty. This limited warranty will not reimburse you for the cost of any inconvenience, food, personal injury or property damage. If an original replacement part or product is not available, a comparable replacement part or product will be provided.

### ITEMS MANUFACTURER WILL NOT PAY FOR:

1. Service calls to your home, business, or general location of the product.
2. Repairs when your product is used for other than normal, single-family household or residential use.
3.
